DEADLINE for individual presenter abstracts: October 14, 2019*

DEADLINE for chairs to review and finalize session: October 16, 2019*

**All deadlines occur at 5:00 PM Central*

General Requirements for all Submissions

- It is the responsibility of the chair/moderator to keep the schedule approved by the Program Committee.
- Presentations are solely education based. The use of any advertising, trade names, or product-group message association is prohibited; this rule will be strictly enforced.
- All presenters' and co-authors' disclosures must appear on the first slide of the presentation. Slides will be reviewed in the speaker ready room to ensure compliance.
- Once a session is accepted, speaker changes are NOT allowed unless approved by the Program Committee Chair.
- Speakers are limited to no more than two (2) speaking roles in the Conference (Keynote Lecture, Parallel Symposia and Brainstorming Sessions).
- Commercial logos (e.g. Company) are not permitted to appear on meeting materials, including presentation slides.
- Speakers who have their session accepted will be eligible for a reduced registration fee. Regrettably, no financial assistance can be provided for travel or other expenses. Please note that a chair can also double as a speaker, but that chairs who are not speaking in the session are not eligible for the reduced registration fee

Brainstorming Sessions

- This is a 60-minute interactive session.
- Each Brainstorming Session is a moderately formal 1-hour session that includes two (2) speakers and one (1) chair/moderator who can also double as a speaker.
- A Brainstorming session should be structured to incorporate ample audience member discussion/participation, e.g. short introduction of 1 minute, two presentations of 15 minutes followed by 29 minutes for discussion. Alternatively, it can be organized as a debate.
- An individual **cannot** be listed as a speaker on more than **2 accepted proposals** (Keynote Lecture, Parallel Symposium, Brainstorming Session). If a speaker is listed on more than 2 accepted proposals, the speaker will need to find a suitable replacement which can be approved by the program chairs.
- There is a limit of 250 words for the text of the overall brainstorming session overview.
- Individual abstracts must be submitted in English, are limited to 250 words, and may include section headers for "Aims," "Methods," "Results" and "Conclusion" as appropriate to the content. **No figures, tables or references are to be included in the abstract.**

Symposia and Brainstorming Session Topics

In accordance with expanded theme of the 22nd Annual ISBD Conference: *20/20: Vision for Bipolar Disorder and Depression*, we would like to highlight that, in addition to our focus on bipolar disorder, we are now also accepting proposals that focus on mood disorders more broadly, including major depressive disorder and other disorders that commonly co-occur with bipolar disorder.
