# **CMSA Fellowship Submission Checklist**

- Complete the Online Application Form: all fields are complete, if applicable, and includes your signature.
- Attach Your Curriculum Vitae (CV) and Current Professional Headshot for Publication
  - CV should minimally include name, education, employment history, publications, presentations, community service, professional activities, and honors/recognition.
  - Your Headshot should reflect your professionalism and be submitted in a print-ready format. Selfies are not accepted.
- Attach Three (3) Letters of Recommendation: from three individuals from different categories that have interacted with you in a professional capacity with first-hand knowledge of your contributions to the field of case management. Letters of Recommendation should include detailed descriptions of the impact you have made on the professional practice of case management. Consider a senior leader, supervisor, mentor, mentee, professional peer, someone in a leadership position, or another FCM.
- Submit Application with Application Fee of \$350: Please make sure you follow payment instructions when submitting the application online, and if paying by check, ensure it is postmarked by the submission date and made payable to CMSA. Application fee is non-refundable/non-transferable.

#### **Minimum Qualification Criteria:**

- Hold a case management certification from a <u>nationally recognized certifying body</u>.
- Be a current member of CMSA at time of application and have maintained CMSA membership for at least five (5) out of the most recent six (6) years.
- Minimum of ten (10) years in the professional practice of case management.
- Possess professional licensure or hold an advanced health and human services degree.
