**Continuing Education (CE) Professional Workshops:** Please consider proposing a professional development CE training workshop or course for building knowledge, skills and expertise on alcohol-related harm, preventing, and recovering from alcohol misuse and evidence-based treatments for alcohol use disorder. Pre-conference Workshops may be proposed for a 4- or 8- hour blocks. RSA can help with developing course materials. Course Director benefits include free RSA conference registration and coverage of one hotel night.

- New developments in pharmacotherapies for alcohol use disorder and alcohol detoxifications
- Understanding alcohol effects
- Treating chronic pain and alcohol comorbidity
- Alcohol, Pregnancy and Alcohol Spectrum Disorders
