For Exhibitors:

CERTIFICATE OF INSURANCE: Exhibitors and their authorized decorators must have liability insurance. Each exhibitor must provide a “Certificate of Insurance” listing the Research Society on Alcohol as Additional Insured from showing coverage for the duration of the event, including move-in and move-out days. The minimum requirement is liability and property damage insurance of no less than \$1,000,000 per occurrence.

Satellite Submissions

To maintain the scientific integrity of the RSA Annual Scientific Meeting and ensure that educational content is balanced, accurate, and complementary to the main program, all Satellite Symposia proposed in conjunction with the meeting must undergo review and approval by the Executive Committee.

Satellite Symposia are non-CME educational sessions organized by external institutions, industry partners, or other groups, and are held on Saturday, June 20, 2026. While these sessions may provide valuable scientific updates, it is essential that their content remains distinct from the accredited sessions included in the official conference program.

1. Submission and Review Process

- All Satellite Symposium proposals must be submitted in advance to the Executive Office for administrative review.
- The proposal, including the session title, objectives, speaker list, and supporting organization(s), will be reviewed by the Executive Committee to ensure that:
 - The proposed science does not overlap with topics covered in the main conference program.
 - The content is scientifically sound, evidence-based, and appropriate for the audience.
 - The session maintains educational independence and transparency regarding any commercial support.

2. CME Status

- Satellite Symposia are not eligible for Continuing Medical Education (CME) credit.
- Organizers must clearly communicate that CME is not offered for these sessions in all promotional and program materials.

3. Scheduling and Promotion

- Approved Satellite Symposia will be scheduled only on Saturday, June 20, 2026, subject to space availability and logistical considerations.
- Promotional materials must clearly identify the session as a Satellite Symposium and indicate that it is independently organized and not part of the accredited conference program.
- The Research Society on Alcohol reserves the right to review and approve all promotional language referencing the conference.

4. Scientific Oversight and Non-Endorsement

- The Executive Committee reserves the right to request modifications to ensure alignment with the Research Society on Alcohol's mission and to avoid content redundancy.
- Acceptance of a Satellite Symposium does not imply endorsement of the content, presenters, or supporting organizations by the Research Society on Alcohol or the Executive Committee.

Satellite Session Parameters

Guidelines for topics and parameters to consider when developing a RSA Satellite submission are as follows:

- Novel topic areas pertaining to alcohol science that are not being considered in the regular scientific content of the meeting and requires distinct expertise from RSA regular membership (e.. Machine learning/AI).
- Topics supported by an R13 grant requiring training, education or networking with RSA researchers as part of the goals.
- Alcohol-related large grant-funded groups that include a number of diverse scientists from multiple institutions who are not able to meet at other institutional venues to present and promote their science, to network and collaborate with team partners and form related scientific goals.
- Professional training and education Workshops
- Technical Trainings
- New, innovative content not being covered in the typical content presented at the Meeting

Please note that posters NOT being presented during the Annual Meeting will not be accepted for a satellite session. If you would like to display posters in conjunction with your satellite, they should be submitted and accepted through the process outlined for the Annual Meeting.
